- 3. Qualification:** - MBBS with post graduate Degree/Diploma/DNB in the concerned specialty for Anesthesia & Radiology and MD/DNB (Medicine/Pediatrics) for Cardiology, Neurology & Nephrology from a recognized University/Institution and should have a valid registration with Delhi Medical Council and the candidate must not have completed 03 years Senior Residency in any recognized institution including regular & ad-hoc period.
- 4 Pay Scale:** - PB-3 of Grade Pay Rs. 6600/- plus usual allowances as admissible under the rules per month.
- 5 Age Limit:-** As on 30th April - 2016, 40 years for General category, 5 years relaxable for SC/ST and 3 years for OBC Candidates (belonging to Delhi only) and for PwD as per admissible rules of Govt. of NCT of Delhi/GOI.
- 6 Tenure:** - The tenure of senior residents is for a period of 3 years including any service rendered as senior residents earlier on ad-hoc/regular basis in any recognized institution. The appointment will be initially for 89 days may be extendable up to a maximum period of 3 years subject to satisfactory performance of work and conduct report.

- 7 In case of non availability of fresh candidates, the candidates who have completed 3 years of senior residency may also be allowed to appear in the interview as fresh candidates.
- 8 Separate merit list would be prepared for the candidates who have completed their senior residency for 3 years.
- 9 Firstly the list containing the names of the fresh candidates would be exhausted for the appointment and the second list would be used only after that.
- 10 In case the tenure period completed is less than 30 days security money will be forfeited and no experience certificate and no salary will be provided for that period.
- 11 All appointment of residents from the second list will be for maximum 1 (One) years only, it would not be renewable after one year.
- 12 The vacancy may be vary as per need of hospital.
- 13 One post for physical disabled is reserved as per Govt. rules.

14. All the eligible candidates should report in the office of the Director, JSSH at 09.00 AM To 10:00 AM for registration on the day of interview.
15. SC/ST certificates issued from Judicial/Revenue authorities shall only be accepted.
16. For candidates applying for OBC category, the certificate must be issued by the Competent Authority of Govt. of NCT of Delhi. Further, the certificate must have been issued before the date of interview.
17. For person with disability (PwD) candidate relaxation is admissible as per Govt. of India rules.
18. The candidates who are already in Govt. service should submit an NOC from the employer.
19. **Candidates are required to bring self attested copies all original certificates and testimonials along with two passport size photographs on the date of interview.**
20. The posts will be filled up in phases as per availability of vacancies.
21. Other service conditions will be applicable as per service conditions prescribed from time-to-time by the Govt. of NCT of Delhi.
